



MOU BETWEEN UNIVERSITAS RIAU WITH NIPPON KOEI Co. Ltd.

On this Memorandum of Understanding (hereinafter, referred to as the MoU), on Thursday, the eighteenth of January in the year two thousand and twenty-four (18-01-2024), at Pekanbaru, the undersigned:

1. Prof. Dr. Sri Indarti, SE., : As the Rector of Universitas Riau, appointed based on the Decree of the Minister of Education. Culture. Research Technology of the Republic of Indonesia (Number 73644/MPK.A/KP.06.02/2022) dated December 14, 2022 concerning the Appointment of the Rector of Universitas Riau for the Period of 2022 - 2026, in this case acting for and on behalf of Universitas Riau located at Jl. HR. Soebrantas, Bina Widya Campus Km. 12.5 Simpang Baru, Pekanbaru, 28293, hereinafter referred to as the FIRST PARTY

: General Manager of International Environment Department, Nippon Koei Co. Ltd., in this case acting for and on behalf of Nippon Koei Co. Ltd., domiciled at 5-4 Kojimachi, Chiyoda-ku, Tokyo 102-8539 JAPAN, hereinafter referred to as the

SECOND PARTY

The FIRST PARTY and the SECOND PARTY, hereinafter referred to individually as the PARTY and jointly as the PARTIES, agreed to sign a MoU in the field of implementing the Tridharma of Higher Education and Human Resource Development, with the following provisions:

Article 1 AIM AND OBJECTIVE

(1) The purpose of this MoU is to build a joint commitment to cooperate in developing regional resources and campus resources through the Tridarma of Higher Education, namely the fields of Education, Research and Community Service.

(2) The objectives of this MoU are:

- a. to implement and improve the implementation of the Tridarma of Higher Education;
- b. to provide opportunities for the academicians of the PARTIES' universities to implement science and technology; and
- c. institutional development, development and improvement of community welfare.

Article 2 SCOPE OF WORK

The scope of the MoU includes:

- a. Education, teaching and research;
- b. Community service;
- c. Human resource development; and
- d. Cooperation in other fields agreed by the PARTIES.

Article 3 PLAN OF ACTION

- (1) Implementation of activities may involve all faculties and study programs/and or related units within **PARTIES** and will be followed up and regulated in a Memorandum of Agreement (hereinafter, referred to as the MoA) through officials appointed and authorized by **PARTIES**.
- (2) MoA as referred to in paragraph (1) shall at least regulate the procedures, mechanisms, positions and responsibilities of the PARTIES.
- (3) Provisions relating to patents or other Intellectual Property (IP) including its protection will be regulated in a separate MoA which is the implementation of this MoU.

Article 4 DURATION

This MoU is valid for a period of five (5) years from the date of signing, and may be extended based on the agreement of the **PARTIES**.

Article 5 FUNDING

Financing related to the follow-up of this MoU is determined jointly according to the needs agreed by the **PARTIES** and outlined in MoA.

Article 6 FORCE MAJEURE

In the event of force majeure due to natural disasters such as floods, landslides, tornadoes, forest fires, earthquakes, riots, volcanic eruptions, wars and or due to government policies that are beyond the ability and can disrupt the smooth implementation of this collective agreement, the **PARTIES** will conduct deliberations which are then set forth in a joint decision and are an integral part of this collective agreement.

ARTICLE 7 NOTICES AND CORRESPONDANCES
