In this Memorandum of Understanding, the two parties above are collectively named "**THE PARTIES**"

THE PARTIES recognizing the value of academic and educational collaboration and exchange between the two organizations as well as facilitating exchange of ideas, academic activities, students and lecturers/staff.

Now, THE PARTIES agree to abide and conform the following:

1. Establishing academic and scientific cooperation and exchange in nursing area, such as in teaching, research, and other scientific activities.
2. THE PARTIES agree to exchange academic materials such as scientific publications, curricular information and pertinent research report.
3. Each organization will invite the other, if appropriate, to participate in academic activities such as guest lectures, discussions, or conferences.
4. THE PARTIES will assist development and activities of research and teaching within THE PARTIES.
5. School of Nursing, Riau University may send selected lecturer/s to pursue PhD at School of Nursing, The Hong Kong Polytechnic University at mutually agreed cost; and THE PARTIES will support the selected lecturer/s to obtain scholarships.
6. In exchange and study visit of lecturers and students, THE PARTIES agree to finance the exchange program based on mutually agreed cost.

7. Each organization is responsible for the nomination of their own visiting lecturers/staff and students.
8. Matters arising related to implementation of this MoU shall be negotiated and agreed in writing between THE PARTIES.
9. This MoU shall take effect for 3 years beginning from the date signed below and may be extended for further period/s upon mutual consent in writing by THE PARTIES. It may be revised upon mutual consent. Either party may terminate this MoU by giving a six-month prior written notice to the other party. Such termination shall not affect the validity and continuity of any incompletely discharged obligation agreed upon by THE PARTIES before termination.
